## TERMS & CONDITIONS FOR TRANSPORTATION SERVICE

### Rate Card

Round trip : 2300\$/year - declining scale from 2nd child (2nd child \$1850, 3rd child \$1250)

- 1 child registered: \$2300
- 2 children registered: \$4150
- 3 children registered: \$5400

One way morning or one way afternoon is \$1250.

- No refund for occasional interruptions of the transport service.
- Each single trip will be charged \$15/each ride
- No refund after October 1st, 2024.

### Terms & Conditions

LFT students from 4 years old can register for school buses.

Parents are required to review the following terms and conditions with their child(ren) prior to using the transportation service offered by LFT & First Student.

For any changes to your child's bus schedule, please send a message before 1pm to: [transport@lft.ca](mailto:transport@lft.ca) with the last name, first name, class and the bus line number.

- Neither First Student Company nor LFT will be liable for delays caused by accidents, breakdowns, detours, bad highway conditions, snowstorms, traffic congestion, or any other conditions beyond our control, and cannot guarantee the specified time of arrival or departure. First Student Company and LFT will, nevertheless, endeavor to maintain the published schedule.
- First Student Company and LFT ensure a school transport service to the pick-up addresses indicated in the registration form.
- Any damage or deterioration caused by passengers, inside or outside the bus, is the direct responsibility of the students and their families, as well as the cost of repairs paid to the operator and compensation for any interruption in service. Students are responsible for keeping the bus clean throughout the trip. In the event that this is not done, a cleaning penalty will be charged to the student's family/guardians. This penalty is due upon receipt of the invoice (payable to First Student Inc.).
- Students are required to remain seated at their assigned places with their seatbelt on during the entire trip and avoid any noise that would disrupt the bus driver and jeopardize the other students' safety. The driver, with LFT's agreement and after contacting the parents/guardians, has the right to deny transportation to any disruptive person who is abusive or poses a safety hazard to other passengers. There will be no refund authorized.
- First Student company as well as LFT and LFT staff cannot be held responsible for any injury, damage or loss of the children's personal belongings, provided that every precaution has been taken by the staff of LFT to avoid such damage or loss.
